Scholar Sponsors

The Scholar Sponsorship program requires a minimum commitment of \$25,000, payable over a period of not more than five years. The contribution can be made in one payment, or a series of equal semi-annual or annual installments. In return, **Scholar Sponsors** receive the following benefits:
